## THE WORLD FORUM FOR ETHICS IN BUSINESS

# Twenty years of advocacy and action on ethics, good governance and shared value in business, and beyond.

Our first symposium was launched inspired by Sri Sri Ravi Shankar in Bangalore, India. Three years later, we moved the venue to the European Parliament in Brussels in 2006. This has been our main advocacy platform since.

In January 2010, stakeholders from previous conferences joined forces and established a new independent organisation, the World Forum for Ethics in Business, *WFEB*.

Since then, a series of symposia have been held annually at the European Parliament, and around the world. We examine whether business and ethics are complementary or contradictory. We also explore new ways for business leaders to evolve sustainable, socially responsible, and also profitable leadership styles for their organisations.

The organisation also aims to provide participants with a wide range of tools that can empower them personally as leaders, recognising that paradigm shifts in society are based on individual transformation.





## TWENTY YEARS OF ADVOCACY AND ACTION AROUND THE GLOBE

Since 2006, the WFEB conferences has been held at the European Parliament in Brussels annually. In addition, satellite conferences have been held in thirteen countries across the globe.




In 2017, WFEB expanded its focus area once again and held its first conference on ethics in innovation in Munich, Germany.

The ethics in innovation series continued in 2018 with the first conference being held in the USA in the Silicon Valley.

In the same year, WFEB teamed up with Anti-Doping Norway and FairSport for the "Anti-Doping in Sports" conference in Oslo, another edition in the ethics in sports conference series which will see its continuation in 2019 as well. WFEB also held an Ethics in Sports Roundtable in Bangalore, India, in January 2019 with leading sport stakeholders from India, Norway and Germany.

## MORE THAN A DECADE AT THE EUROPEAN PARLIAMENT

2006-2019: International Leadership Symposia on Ethics in Business were held at the European Parliament in Brussels annually. The buildings are the only EU institution to be awarded the Environmental Management Scheme (EMAS) certificates for efficient use of energy, water and paper. The Parliament holds offices for 751 members, which represent the second largest democratic electorate in the world.

On 1 July 2013, the WFEB International Leadership Symposium took place at the United Nations Geneva, Switzerland, at the historic Palais des Nations overlooking the lake of Geneva. The Palace is architecturally designed to preside and to hold discussions in the calm atmosphere which should prevail when dealing with problems of an international dimension. The Palace and its buildings constitute the second-largest building complex in Europe, after Versailles.

The WFEB Leadership Summit was held in London, UK at the headquarters of ICAEW, Moorgate Place on 13 November 2015. It is a characterful Grade II listed building designed by Victorian Architect Sir John Belcher RA and built in 1890. The exterior features a carved stone frieze by Hamo Thorneycroft and the interior includes works of art by Eduardo Paolozzi, Gerald Benney and John Piper.

stadium served as host to the 24 September 2015 Ethics in Sports Symposium Berlin. The 1st World Summit on Ethics in Sports was held on 19 September 2014, at the home of the international football community federation, the FIFA Headquarters. This impressive looking

building was designed to have zero-emission, using energy-efficient technologies that blend harmoniously into its park-like surroundings.



## ETHICS IN INNOVATION

The first conference in the Ethics in Innovation series of the World Forum for Ethics in Business was held from 26 – 27 June 2017 at the headquarters of the German Patent and Trademark Office in Munich, Germany (DPMA).

A joint initiative of the World Forum for Ethics in Business, the Max Planck Institute for Innovation and Competition and the Peter Löscher Chair for Business Ethics at the Technical University of Munich, the conference brought together multiple stakeholders to seek answers to ethical questions in innovation.

The current office building of DPMA was created by the Land Office Munich and the architects Franz Hart and Helmuth Winkler as a new building in the years 1954 to 1959 on a plot of a barracks destroyed in the war. The first construction phase consisted of the five-story atrium construction, the second construction phase of the twelve-story high-rise parallel to the Isar. This urban architectural dominant is visible from afar. The building is attributed to the context-conscious and artistically ambitious modernity.

## **ETHICS IN SPORTS**

Sport transcends culture, nation and beliefs. It triggers emotions and facilitates opinion building and inspiration. Sport manifests challenges in the chain of value creation in real time.



Given the immense importance sports has gained in todays' society, a focus on true sportsmanship and the discussion on good governance and ethics in sports have become more relevant than ever. Recognizing the power of sports and its current governing challenges, but also its potential to connect people and help address social issues, WFEB in 2014 launched a new conferences series titled 'Ethics in Sports'.

Subsequently, the first World Summit on Ethics in Sports was held at the FIFA Headquarters in Zurich on 19 September 2014.

Global stakeholders not only discussed burning governance challenges in sports, in particular in soccer, but also emphasized on the important values sports promotes and the enormous potential sports has to solve social problems. In workshops and in panel discussions solutions for the protection of the purity and integrity of sports were discussed and worked out.


To honor true sportsmanship, the Summit also saw the conferment of the first Ethics in Sports Award in the categories Outstanding Individual, Outstanding Organization and Outstanding Teamwork.

Continuing the success of our first summit, a dedicated Ethics in Sports Symposium was organized in partnership with the German football club 1. FC Union Berlin in Germany's capital.

On September 24, 2015 sports personalities, business and political leaders and media representatives headlined the event along with more than 200 participants from fifteen countries to discuss issues in today's sports and how good governance, ethics and human values at the core of all activities can help solve them. One of the core discussion at the Symposium on the topic of 'challenges on and off the pitch' raised the question whether global sports organizations were actually hiding behind the FIFA's governance challenges and therefore do not address their own challenges.

The common understanding was that it is easy to point out mistakes in others; however, it is critical to address ones own issues in first place.

Speaking up for anti-doping, WFEB in 2018 teamed up with Anti-Doping Norway and FairSport for the "Anti-Doping in Sports" conference in Oslo, another edition in the ethics in sports conference series, which will see its continuation in 2019 as well.

Global experts in the anti-doping world met on 25 June 2018 during the '1st Anti-Doping in Sports Conference' in Oslo, seeking for alternatives and valuable inputs to protect clean sports and athletes. The conference was opened by Norway's Prime Minister Erna Solberg.

WFEB also held an Ethics in Sports Roundtable in Bangalore, India, in January 2019 with leading sport stakeholders from India, Norway and Germany to define ways that bring sports to the heights that it deserves in India and internationally, in a manner which represents the true spirit of sports. To further help advance sports in India, a white paper will be developed, focusing on the accessibility and infrastructure of sports in India.

India's Ministers for Sport and Justice, WFEB founder Gurudev Sri Sri Ravi Shankar, Members of European and National Parliament, Top Athletes, Sports Federations as well as former FIFA President Sepp Blatter were among the speaker line-up in this one-of-a-kind event



"United for Ethics in Sports" was the theme of the 6th World Summit on Ethics & Leadership in Sports that welcomed more than 400 delegates from 45 countries to seek a roadmap for protecting the original values of sports, and to unite people through sports in a post-pandemic world riddled by conflict, economic crisis and mental health issues.

Taking place from 13-14 October 2022 in Bangalore, India, the Summit not only focused on bringing attention to the critical challenges related to sports governance such as corruption, doping and human rights, but also recognize the good that sports stands for by celebrating positive role models with announcing the winners of the Ethics in Sports Award 2022.

"Sports can be that one thing that can bring people together. But today sport is played like a war and wars are waged like a sport," said Sri Sri Ravi Shankar, founder of the World Forum for Ethics in Business. "Players should play with a sense of responsibility and have a sense of sacredness towards their viewers and fans. Ethics is simply not doing what one does not want to be done to them, and this awareness is very important," he added.

Kiren Rijiju, Minister of Law and Justice, Government of India, and former Sports Minister with the Government of India shared his views on the need to encourage a culture of sports in India, creating career opportunities within the sports ecosystem for players to take up roles as coaches, managers, sporting businesses and for a diverse viewership in sports outside of cricket. "India has a rich history and tradition of sports that goes back to ancient times. But over the years, the evolution of the society didn't bring sports culture in the country to the extent we would desire," he shared.

The Award was instituted in 2006, and is presented annually at the International Leadership Symposium organized by the World Forum for Ethics in Business at the European Parliament in Brussels.

In 2014, for the first time, WFEB recognized outstanding

sustainable contributions in the sports arena and once again in 2016 and 2018. The Ethics in Sports Award recognizes an organization an / or individual that have been a leading role model in radiating and embodying ethical behavior in life and in the sports area. The recipients have inspired people to observe and practice human values, and to give equal, if not greater importance, to human values vis-à-vis success in sports. Winners are selected by the Board of Directors of the WFEB.

## Redefining the place for ethics in the 4.0 era

A call for ensuring a human face in the era of artificial intelligence marked the inaugural series of the first "Ethics in Innovation Conference – Innovation 4.0" that took place from 26-27 June 2017 at the German Patent and Trademark Office in Munich, Germany.

A joint initiative of the World Forum for Ethics in Business, the Max Planck Institute for Innovation and Competition and the Peter Löscher Chair for Business Ethics at the Technical University of Munich, the conference brought together multiple stakeholders to seek answers to ethical questions in innovation.

More than 300 global thinkers and leading experts from academics, business, politics and NGOs deliberated on critical concerns about the new era of the fourth industrial revolution the humanity is set to enter. At a time when the world is on the verge moving into the era of Artificial Intelligence, the conference explored answers to important questions, such as, "Should growth be the main guiding principle for the 4th industrial revolution?", "How do we make it more humane?", "What type of leadership do we need to create to deal with this novel situation?" and "What type of education do we need in order to cater to the needs of the changing society?".

The "Ethics in Innovation Conference 2017" also saw 54 selected students and young professionals from 27 countries leading a session on 'Call of the Youth' and voicing their message to today's decision makers. The participating youth leaders had the opportunity to undergo holistic leadership training and prepare their intervention along with interactions with global leaders three days prior to the conference at the "World Youth Forum on Ethics in Innovation". Over 350 youth leaders from more than 30 countries have already participated in the World Youth Forums in the past few years.




# ETHICS IN INNOVATION IN THE SILICON VALLEY

In dedicated keynote speeches and interactive roundtable discussions more than 200 leading CEOs, impact investors, entrepreneurs and NGO leaders discussed how innovation grounded in ethics can power long term growth, and explored new ideas that can promote human wellbeing and solve the biggest problems facing our society and planet through innovation.







# WFEB launches a series of dedicated Think Tank discussions to address ethical dimensions of the current pandemic

To help us make sense of the ground shifting beneath our feet as the crisis unfolded and to discuss on how Ethics, Wellbeing and successful Business can be combined, The World Forum for Ethics in Business (WFEB) launched a series of Think Tanks on 8 April 2020.

This includes large scale tree plantations drives, water management and protection including cleaning polluted rivers and rejuvenating dried rivers and zero-budget chemical-free farming that is both economically and organically sound.

And we are approaching potentially irreversible catastrophic thresholds that would place all future generation in a situation that we can call today a planetary emergency. That is one important lesson from what we are facing right now.

We are part of nature. We cannot be outside of nature. We are governed by the 5 elements. Mental health is very important at this point of crisis. #### THE IMPACT OF THE CURRENT CRISIS ON MENTAL HEALTH

Since the outbreak of Covid-19, the pandemic has impacted the mental health of people around the world. Isolation, fear, insecurity, economic turmoil, loss of loved ones and a feeling of powerlessness have determined the lives of citizens globally. Levels of stress and anxiety have risen substantially, including amongst children, young people and healthcare workers. Substance and alcohol dependency are expected to rise, while self-harm and suicide rates among at risk individuals are also expected to increase.

The United Nations warns of a sharp rise in mental illness as a result of the pandemic. The WHO urges that governments should put the issue at the center of their crisis management efforts and calls for increased investment in psychological support and emergency programs, such as therapies via video conference.

Leading experts warn that if we do not address it properly, a mental health crisis could be the next pandemic.

Never before has the importance of mental health been in such forefront of the discussion and experienced a de-stigmatization as with the current pandemic.

With mental health experts distributing their advises through social media livestreams, newspapers around the world sharing tips on how to cope with the psychological implications of Covid-19, or with virtual mindfulness and meditation sessions that sees people around the world turning to find inner peace and resilience – mental health has clearly reached the mainstream in unprecedented ways.

In the current crisis, what needs to be the paradigm shift in mental health support, both from a micro and macro perspective? What are the chances and challenges arising from the pandemic, and what needs to be the roadmap?

This online discussion forum, hosted by WFEB founder Sri Sri Ravi Shankar on 29th May 2020 live on social media., invited leading experts to put into perspective the current implications and consequences of the pandemic on mental health, discussed best practices, and called for urgent changes required in an inevitable scaleup of mental health efforts around the world. Speakers included among others Dr. Katarina Barley, Vice-President of the European Parliament, Dr. Dan Chisholm, Regional Advisor for Mental Health in Europe at WHO, Andrea Euenheim, CHRO at Metro AG, Dr. med Peter Liese, Member of European Parliament; Health spokesperson for the largest political group in the European Parliament and Prof. Bjarne Hansen, Head of the Bergen 4-day Treatment Clinic, Haukeland University Hospital & Professor at The Center for Crisis Psychology, University of Bergen.

The Think Tank called for the urgency to find cost-effective and immediate solutions to address the rise of mental health issues globally.

CONTINUING THE DISCUSSIONS ON THE IMPACT OF COVID-19 ON MENTAL HEALTH

The Power of Breath: Can breathing-based stress management techniques be an answer in the current mental health crisis?

Latest studies by Yale University and the Beth Israel Deaconess Medical Center (BIDMC) published in July 2020 suggest that breathing-based techniques can be an effective tool in reducing stress and depression and support overall mental health and well-being.

How can something as simple and costeffective as our own breath be a remedy in the current mental health crisis? Why are these techniques considered so impactful? And where are these techniques already in use and can be scaled-up as a best-practice for global impact?

To find answers for these questions, WFEB invited experts from the US and Europe who have done significant research and work in this area to a dedicated expert roundtable, The panel comprised of Dr. Emma Seppälä, Lecturer at Yale University and Science Director at Stanford University, James Nestor, Science Journalist and Author of the bestseller Book "Breath" as well as Swami Jyothirmayah, International Director of The Art of Living Foundation and Breathwork & Meditation expert.

The roundtable event saw a dynamic exchange, inspiring case studies of transformation and a presentation of latest scientific studies and practical research done at Yale University on the effectiveness of breathing techniques, in particular a breathing technique called "SKY" (Sudarshan Kriya).

A few days to go till this year's World Mental Health Day, speakers urged that it is more important and mandatory than ever before to bring mental health awareness in the spotlight and turn to solutions and new approaches for prevention and treatment. All speakers commonly agreed that the right breathing techniques can play a significant role in contributing to overall mental health and wellbeing.

Changing paradigms in a pandemic world: More than 2 million viewers from 100 countries attended global virtual summit that brought together stakeholders from all walks of life to discuss and identify new approaches for addressing the pandemic's main challenges. Speakers commonly urged that tackling mental health issues continues to be a key priority



On the occasion of World Health Day on 7 April 2021, the World Forum for Ethics in Business hosted a global virtual summit themed "Changing Paradigms in a Pandemic World: How to regain trust? Health, Happiness & Ethics".

WHO's General Director Dr. Tedros Adhanom Ghebreyesus, Heads of State, Health Ministers, Pfizer's India Managing Director and UEFA'S CSR Director were among the keynote speakers of this event that welcomed more than 150 speakers in dedicated keynote panels and in 25 in-depth workshop deliberations.

The conference was opened with a message by WFEB founder and global humanitarian Sri Sri Ravi Shankar. 'This World Health Day has more significance than ever before. Today when the whole world's health is challenged like never before by the pandemic, the global community has to come together to fight the cause and find the cure', Sri Sri Ravi Shankar's message goes. 'Health has no origin but disease does. Disease occurs when the laws of nature are violated. We need to envision a new world that is physically, mentally & emotionally healthy, and spiritually blossomed. WHO Director-General Dr. Tedros Adhanom Ghebreyesus said in his keynote statement 'It has now been more than 14 months since I declared Covid-19 a global health emergency. But the pandemic has also worsened inequalities in our societies. Vaccine equity is the challenge of our time. The inequitable distribution of vaccines is

Through dedicated keynote panel discussions and interactive workshops on different aspects of the pandemic's impact, the summit brought together leading stakeholders from politics, business, academics and civil societies to challenge the status quo and seek answers for citizen's to better navigate through the pandemic and the time to come. Speakers commonly emphasized that collaboration, solidarity and unity in the fight against Covid-19 are key elements for the global community and must be accelerated to move towards a better, fairer and more ethical tomorrow.

The conference also presented tools and techniques to address the mental health crisis and highlighted the need for scaling-up mental health efforts around the world.




